Media Treason

In reporting issues and events, our Establishment media (including especially “conservative” outlets) diligently suppress the reality of

revolutionary organization and its hidden subversive agenda.

By doing so, they are leading Americans down a road to the same kind of oppression that has caused millions to flee their nations. That is why it’s so important to build Freedom First Society and help others recognize the deception.

Misrepresenting Protests

As one example of media self-censorship, beginning April 11, two front groups — the Democracy Spring and Democracy Awakening coalitions — organized protests in our nation’s capital to provide “pressure from below” on Congress. More than 1,300 peaceful protestors were arrested.

The Democracy Awakening website claimed it was a coalition of “more

than 200 organizations representing a diverse array of movements.” Of the D.C. event, it boasted: “Today, we’re fighting for change on many fronts — for action on climate change, racial justice, workers’ rights and fair pay, safe food and water, health care, peace, immigration reform and improvements in education.”

The whole tone of the highly organized event, consisting of teach-ins, demonstrations, and music, was obviously left-wing revolutionary.

Spring Financial Appeal



Media complicity: In April, the Democracy Spring and Democracy Awakening coalitions, the latter boasting support from “more than 200 organizations,” converged on our nation’s capital for several days of workshops, speeches, rallies and demonstrations to provide “pressure from below” on Congress. Despite the obvious revolutionary flavor of the event, media reports merely repeated the desired messages of the organizers regarding a variety of “hot” issues. Americans were not informed of an easily discovered subversive agenda targeting our freedom, nor how such an ambitious event was funded and organized.





Yet, outrageously, media reports merely repeated the coalitions' advertised claims at face value, not even discussing how the event was organized and funded. As expected, the reports failed to alert Americans to an easily discovered subversive agenda and strategy designed to lead us into slavery.

Openly Championing

Some media outlets even openly champion the ostensible revolutionary agenda. On April 18, the editorial board of the *New York Times* published an op-ed entitled "Transgender Bathroom Hysteria, Cont'd.," decrying state legislative efforts to prevent transgender males from using the public bathrooms of their choice:

After the withering backlash against North Carolina for passing a discriminatory law against gay and transgender people last month, it would stand to reason that lawmakers and governors in other states would think twice before peddling bills that dictate which restrooms transgender people can use. And yet, state legislators in Tennessee, Kansas, South Carolina and Minnesota are pushing similar absurd measures.

Of course, the reality is quite differ-

ent. Specifically, the Charlotte, North Carolina City Council had passed an ordinance allowing transgender males to use the bathrooms of the gender they identify with. The state actions were *triggered* by public outrage over this revolutionary assault.

The *Times* editorial further helped intimidate any resistance to this aggressive transgender agenda by claiming widespread condemnation for such resistance (a variation of standard revolutionary tactics):

The hastily passed bill in North Carolina, which said people must use public restrooms based on the gender on their birth certificate and prohibited local governments from passing nondiscrimination ordinances, has been roundly condemned by corporate leaders, civil rights groups and religious leaders.

The law cost the state hundreds of jobs after PayPal scrapped plans to open a global hub in Charlotte and Deutsche Bank suspended plans to expand its operations in the state. Executives from 80 major companies, including Google, Apple and Facebook, wrote a letter to the governor of North Carolina, Pat McCrory, urging repeal of the law, arguing that it would make it "far more

challenging for businesses across the state to recruit and retain the nation's best and brightest workers."

Clearly, the Establishment *Times* wanted us to believe that such corporate support for the transgender agenda was in no way engineered. Yet the 2015 Annual Report of the Council on Foreign Relations lists Deutsche Bank, Google, and Facebook as "Corporate Members."

The *Times* editorial further reported that the full force of the federal government was poised to punish North Carolina's resistance to this outrageous invasion of decency by withholding federal monies: "Federal agencies are considering steps they might be required to take because of the discriminatory law."

Unfortunately, most resistance to the transgender assault will be superficial Level I rather than exposing the revolutionary agenda, strategy, objectives, and influence that are using the discrimination issue to beat down defenders of common sense.

And just to be clear: What is the revolutionary agenda that is being ignored? Without going into detail, we are facing a Godless Conspiracy to enslave mankind that promotes moral decline, homosexuality, and scorn for religious teachings as a well established path to its victory.

Concealing the Real Agenda

A recent (4-9-16) report by Reuters also deceived its readers by censoring underlying agendas targeting our freedom:

A federal judge on Tuesday approved an agreement between the U.S. Justice Department and Ferguson, Missouri, to reform the city's police department....

The largely black community of Ferguson erupted into violent protests in 2014 after a grand jury chose not to indict white Ferguson

police officer Darren Wilson in the fatal shooting of unarmed 18-year-old African-American Michael Brown....

A number of U.S. cities have entered into police reform pacts, including Seattle, Washington and Albuquerque, New Mexico.

The Reuters report makes no mention that these consent agreements are part of a decades-long revolutionary campaign to nationalize our local police departments and make them accountable to Washington rather than their local communities.

Moreover, Reuters apparently expects casual readers to accept that “the largely black community of Ferguson erupted into violent protests” without any organization, and certainly without protest organizers pursuing a hidden, subversive agenda.

Man-made Climate Change

In recent weeks, Americans have been bombarded with scary stories claiming that the impact of man-made climate change will be worse than expected. We are told that the supporting science is settled, despite continued irresponsible opposition from a small minority of “deniers,” mostly in the pocket of the fossil fuel companies.

Challenging this climate panic, a recent (4-14-16) editorial in *Investor’s Business Daily* (IBD) was unusually refreshing:

James Hansen, the famed NASA scientist who stirred the climate scare when in 1988 he told a Senate committee that “global warming” — yes, he used those words — “is already happening now,” has never backed off his claims, despite the fact that he’s been demonstrably wrong....

The narrative since that day in 1988 is that Earth is entering a dangerous warm era created by man’s carbon dioxide emissions. Every heat wave, cold snap, drought, hurricane, heavy snow, torrential rain, and change in sea

level has been supposedly caused by man. And all are allegedly unprecedented events.

Except they’re not. It’s been warmer, and extreme weather has visited us before, all in a time long before man began to drive cars and operate power plants that helped move him from an almost primitive existence to a modern one. Hansen has even admitted this.

Although welcome, the IBD editorial unfortunately was all at the “see-no-evil” level I.

While it is not our role to be arbiters of *genuine* scientific dispute, we have and do point out that, Establishment claims to the contrary, the science is not settled (see, for example, our online review, “Some Welcome Relief at Hand,” of Lawrence Solomon’s *The Deniers — The world-renowned scientists who stood up against global warming hysteria, political persuasion and fraud.* * *And those who were fearful to do so.*)

The critical issue that should concern all of us, however, is that the Insiders are using the global warming scare as a pretext for an immense power grab to build their totalitarian world order and eliminate the opposition of a prosperous American middle class (see, for example, *Masters of Deception*, Chapter 8).



Even after they adjourn, we should turn the attention of our legislators to the nonsense of the arguments being made for a Con-con. Above all, tell them that the problem is not the Constitution: it's the disobedience of our federal government, particularly Congress, to it. We must get more constituents to insist that our congressmen uphold their oath to defend our Constitution!

Congress: Just Vote the Constitution!

House GOP leaders continue to schedule mainly low-profile legislation that minimizes the chances of party unrest.

The House GOP leadership has long been unwilling to grapple seriously with out-of-control government, a principal root of our nation's problems. Most of the bills that come before the House are not intended to become law,

but instead merely to support election campaigns.

We must demand that our congressmen challenge the Establishment grip on both parties by insisting on using the congressional power of the purse to rein in *unconstitutional* spending.

At the moment, it doesn't look like the House will pass a FY 2017 budget. However, the appropriations committees in both the House and Senate are working on annual spending bills. Only a handful of those bills seem certain to advance in the House.

That means at some point there will be pressure to pass another continuing resolution or omnibus spending bill. One message to our representatives should be:

Don't vote for any omnibus spending measures. Force the Senate and the president to deal with any measures already passed by the House. Don't create the opportunity with an omnibus bill for the liberal big-spenders to blackmail the House with the threat of a complete government shutdown if they don't get their way.

It could really help to expand our influence if we can get FFS on the radar screen of congressional staff. Accordingly, we suggest including a copy of our *Action Report* with your mailings, whenever the *Report* provides appropriate support for your letter.
