A Horrendous Scam!

The United States and China will work together to get nuclear-armed North Korea to take “a different course,” U.S. Sec. of State Rex Tillerson said on Saturday, softening previous criticism of Beijing after talks with his Chinese counterpart. — Reuters (3-18-17)

For decades, a horrendous scam aimed at our enslavement — the promise of world harmony and prosperity through world governance — has been victimizing America. And so far, this scam continues right on course in the Trump administration.

At the outbreak of World War II, the Council on Foreign Relations took control of the U.S. State Department (now headed up by Tillerson). Insiders at the CFR used World War II to establish their United Nations, an alliance of predominantly despotic

regimes, as a steppingstone toward Insider-controlled world government. And in the war’s aftermath, these same Insiders disarmed our ally Chiang Kai-shek and helped Mao Tse Tung seize control of China.

China and other Insider-supported totalitarian states have carried out crimes against humanity that defy description. Professor R.J. Rummel estimated the *civilian* deaths perpetrated by such regimes during the first 80 years of the 20th century at between 170 million and 360 million, including at least 35 million Chinese! The indictment against the world-order architects goes on and on. We ignore their scam at our peril.

Post Cold-War Pretexts

With the planned end of the Cold War and the ostensible demise of

the Communist threat, the Insiders needed new global crises to drive their agenda for world control. Among the pretexts adopted were terrorism, drug trafficking, and the threat of environmental catastrophe. (See *Masters of Deception*, Chapter 8 Post Cold-War Pretexts.) What most Americans fail to realize is that the Insiders *want and need* these problems. These problems are not to be solved, as long as they serve Internationalist designs.

Consider the scourge of terrorism.

The CFR long covered up the Soviet role in orchestrating the international terrorist movement. Then “[i]n January 1989 ... Secretary of State George Shultz (CFR) joined representatives of 34 other nations in Vienna to condemn ‘as criminal all acts, methods, and practices of terrorism, wherever and by whomever committed’ and agree that ‘terrorism cannot be justified under any circumstances.’ ... Among the signers of the anti-terrorist agreement were representatives from the Soviet Union, Bulgaria, Czechoslovakia, East Germany, and Hungary — all supporters of international terrorism.” (*Masters of Deception*, p. 116.)

So what are the chances that Tillerson and the Red Chinese murders will convince North Korea to become a nice neighbor — unless, of course, it serves an even more sinister design? Absolutely nil!

“Reform the United Nations”

In recent decades, growing support for U.S. withdrawal from the United Nations has been repeatedly deflected by calls to *reform* the UN. Accordingly, we see the administration’s announced plans to get tough with the UN as primarily posturing to capture conservative support. As usual, the totalitarian purpose of the UN is obscured in this report:

Trump administration deliberations about whether the United States should quit the United Nations’ Human Rights Council over its anti-Israel obsession reflect a welcome new U.S. approach to Turtle Bay....

Of the U.N.’s longstanding and pervasive anti-Israel bias, Haley told reporters that Washington is staking out a firm new position: “I’m here to say the United States will not turn a blind eye to this anymore.... I’m here to emphasize the United States is determined to stand up to the U.N.’s anti-Israel bias.” — USNews.com, 3-7-17

“Strong Support” for NATO

As further evidence that the Internationalist agenda is alive and well in the Trump administration, consider this report:

Trump used his first meeting with Merkel to affirm his “strong support” for NATO and to declare he is not an “isolationist” on free trade after a campaign in which he questioned U.S. policies on multilateral security and economic alliances in Europe and elsewhere.

NATO’s architects at the CFR envisioned such regional alliances as steppingstones to world government: “While Under Secretary of State Robert Lovett was working behind the scenes to establish the NATO alliance, [the CFR’s] *Foreign Affairs* registered its support: ‘[A] regional organization of nations, formed to operate within the framework of the United Nations, can only strengthen that organization.’” (*Masters of Deception*, p. 136.)

In Summary

The drive for totalitarian world government is not a minor concern. The Internationalist Insiders have tons of blood on their hands. Their character as would-be rulers has been on full display. Politicians who advance the

Internationalist power grab cannot be excused simply because they feign opposition to a revolutionary *domestic* agenda.



The claim that the federal government should provide welfare has no basis in the design of America’s Founders. However, socialists rely on precisely that notion to create an ever-larger federal monster.

Unfortunately, hardly anyone in politics today acknowledges that

to make America great again (and safeguard our liberties) we must get the federal government entirely out of the health care and health insurance businesses.

Ravages of Obamacare

Obamacare took federal welfare and control of the health insurance market a giant step forward:

The Affordable Care Act expanded coverage to about 20 million more Americans by setting up state exchanges, where people could buy insurance with subsidies based on their income, and by giving states federal money to expand Medicaid to more of their populations.

Since the law's inception, Republicans have campaigned on the need to *repeal* Obamacare. Unfortunately, many have also embraced the goal of *replacing* it, thereby affirming that Obamacare addressed a legitimate need. More than a year ago, Rep. Raul Labrador

correctly emphasized: “Replacing Obamacare is just actually replacing it with another government-run program and I think some of us as conservatives don’t want the government to be running that.” — Roll Call, 1-7-16

Bipartisan Treason

For decades, both parties have supported unconstitutional federal expansion.

One astute analyst recently assailed the Republicans for regularly following a ratchet pattern. On the campaign trail, they rail against Democrat-supported big-government. But once they gain the majority, their leadership simply adopts the previous socialist inroads as the baseline, makes a few tweaks, and calls it progress.

Opposition limited to defending against *further expansion* of federal authority can only lead to disaster. Major rollbacks must be the goal.

The American Health Care Act

So now that the Republicans control the White House as well as the House and the Senate, what about their proposal, the American Health Care Act?

Presented as part of a GOP plan to repeal and replace Obamacare, the AHCA would do neither. More than a dozen congressmen protested the betrayal:

[M]embers of the House Freedom Caucus, backed by conservative Sens. Ted Cruz of Texas, Rand Paul of Kentucky and Mike Lee of Utah, have said that it doesn’t keep faith with the GOP’s promise to unravel Obamacare.

“It’s Obamacare in a different format,” Representative Jim Jordan of Ohio ... said in a phone interview.

The House Republican leadership plan — quite frankly it is the largest welfare program that

Republicans have sponsored in the history of the Republican Party. — Rep. Mo Brooks (Ala.), MSNBC, 3-16-17

Conservative Review Senior Editor Daniel Horowitz makes a strong case that the AHCA is actually worse politics and policy than Obamacare. In a March 7th article, “RINO-Care: A more insolvent version of Obamacare ... except this time GOP owns it,” Horowitz points out that the Ryan plan, with strong support from President Trump, would leave most of the regulatory structure and the exchanges in place.

And once the Republicans take ownership of this massive entitlement expansion, the challenge to undo the damage increases dramatically.

See No Evil


Yet the betrayal is even worse. Socialism is not a misguided humanitarian plan promoted by do-gooders. It is an evil deception. The humanitarian pretext cleverly serves to advance and cloak a totalitarian power grab.

Such is especially the case with socialized medicine. The socialist breakthrough came in 1965 with the enactment of King-Anderson (Medicare), but only after decades of infiltration and preparation by Fabian Socialist organizers, their Americans for Democratic Action front, and radical union organizer Walter Reuther. (See *Media-Controlled Delusion*, Chapter 1 Socialized Medicine.)

What to Do?

Currently, there is nowhere near a majority in Congress with the will to do the right thing — get the government out. Many Republicans will seek compromise with liberals in violation of the Constitution, claiming they are negotiating the best deal possible.

But that is a betrayal, too. The deal may *appear* to slow down our enslavement, but it deceives the public. The only responsible course for a principled congressman is to

vote against the continuation of unconstitutional programs.

Despite lobbying by President Trump, Vice President Pence, and House Speaker Ryan, a number of conservative congressmen steadfastly refused to support the Ryan plan. As we go to press, House leaders twice abandoned a scheduled vote due to insufficient support.

Achieving a majority of principled congressmen in Washington cannot occur until there is more understanding created back home. Former Congressman Lawrence P. McDonald showed that he could vote on principle and get re-elected, despite Establishment attacks, because his district had a strong base of informed voters.

As the patriot Robert Welch emphasized, “All we must find and build and use, to win, is sufficient understanding.” And that takes strong organization that is committed to correct principles and understands the forces working to enslave us.

Save Our Constitution! by Andrew Carver

There is great news! Following Delaware’s 2016 example, New Mexico has just rescinded all its prior calls for an Article V constitutional

convention! Since those prior resolutions included a call for a BBA (Balanced Budget Amendment) Con-con, this rescission reduces the current number of BBA calls from 29 to 28! Many thanks to Julianne Young, Nancy Dunn and other FFS members who reached out to New Mexico legislators, encouraging them to pass the rescission measure.

Let’s keep pushing for rescissions! Many strategic benefits accrue from going on the offensive, even if you lose the first battles: In our Con-con fight, seeking rescissions will have such benefits as: 1) creating an opportunity for educating legislators on why an Article V Con-con is dangerous; 2) forcing Con-con proponents to take resources and time away from passing their own resolutions to fight our rescission resolutions; and 3) stopping the momentum of Con-con calls around the country.

Please remember that our website has TWO pages for current Con-con measures: one page has the measures we SUPPORT, including rescission resolutions. (You can find both pages under the main-menu item “Measures Targeted by Campaigns.”) As of this writing, there are at least seven viable rescission measures that various states are considering. So please check out this page and learn about

these measures — then take action to support them!

Our goal is to reduce greatly the number of current state calls for an Article V Con-con. And while that requires rescission of past calls, it also requires defeating current and future call-measures — a strategy of BOTH offense and defense — until finally, we ROUT this broad push for a Con-con!
