**Complicity in revolution:** Media coverage of anti-Trump protests *helps* revolutionary organization simply *by ignoring it*. The protests are thus able to posture as spontaneous, sincere outpourings of concern, with no hidden agenda. The complete tactic, effectively used in the Communist takeover of Czechoslovakia during 1945–48, also requires sympathetic allies in Congress. This “revolutionary parliamentarianism” has long been practiced in this country with continuing success.

As previously discussed, the major media *help* revolutionary organization *by ignoring it*. Organized protests are thus able to generate effective pressure from below by appearing to be spontaneous, sincere outpourings of concern, with no hidden agenda.

### Activist Training Manual

An interesting exception was a recent story (2-18-17) in the *New York Post*, now owned by former CFR Rupert Murdoch’s News Corp. and designed to appeal to, and neutralize, conservatives. The story title was “Obama-linked activists have a ‘training manual’ for protesting Trump.” According to *The Post*:

An Obama-tied activist group [Organizing for Action] training tens of thousands of agitators to protest President Trump’s policies plans to hit Republican lawmakers supporting those policies even harder this week, when they return home for the congressional recess and hold town hall meetings and other functions....

The manual, published with OFA partner “Indivisible,” advises protesters to go into halls quietly so as not to raise alarms, and “grab seats at the front of the room but do not all sit together.” Rather, spread out in pairs to make it seem like the whole room opposes the Republican host’s positions. “This will help reinforce the impression of broad consensus....”

As *The Post* reported, OFA boasts more than 250 offices nationwide and more than 32,000 organizers, with another 25,000 actively under training....

These aren’t typical Black Lives Matter or Occupy Wall Street marchers, but rather professionally trained organizers who go through a six-week training program similar to the training — steeped in Alinsky agitation tactics — Obama received in Chicago when he was a community organizer.

Where we part serious company with *The Post* story is its claim: “Obama appears to be behind the anti-Trump protests.” This misdirection serves to hide the immense conspiratorial forces working to destroy our freedom. At the street level, it ignores the day-in, day-out organization that has taken place on our college campuses over the past century. Instead, we ask: “Who is behind Obama and ‘his’ foundation?” “What revolutionary forces did the foundation recruit from?”

### Socialized-Medicine

According to *The Post*, one mission for the anti-Trump protestors is “to bully GOP lawmakers into backing off support for repealing ObamaCare.” However, this pressure from below is much more designed to provide policy makers with *welcome cover* for doing what they are already committed to do — solidify Washington’s grip on America’s health care.

In a recent FFS post, “Repeal and

Accept (Big Brother!),” we warned:

That huge century-long revolutionary investment in government control [of medicine] won’t be reversed unless there is much greater public understanding of the powerful forces and subversive agenda promoting it. Until that happens, the political hue and cry of “Repeal and Replace” will at best mean a small step backwards while accepting much of the socialist progress of the long ObamaCare step — in short, net progress toward universal government-controlled health care.

### Conservative Reaction

A recent (2-18-17) *New York Times* article described still another fallout of the anti-Trump protests — driving “moderates” into the Trump camp. In “Are Liberals Helping Trump?” the *Times* claimed:

Liberals may feel energized by a surge in political activism, and a unified stance against a president they see as irresponsible and even dangerous. But that momentum is provoking an equal and opposite reaction on the right. In recent interviews, conservative voters said they felt assaulted by what they said was a kind of moral Bolshevism — the belief that the liberal vision for the country was

the only right one....

Protests and righteous indignation on social media and in Hollywood may seem to liberals to be about policy and persuasion. But moderate conservatives say they are having the opposite effect, chipping away at their middle ground and pushing them closer to Mr. Trump.

The *Times* even found that reaction in a registered Democrat, a former Bill Clinton supporter, who argued: “[The protestors] are scarier to me than these Islamic terrorists. I feel absolutely disgusted with them and their antics. It strengthens people’s resolve in wanting to support President Trump. It really does.”

But is this reaction really a problem for the Insiders? In their typical media-supported professional wrestling matches between Democrats and Republicans or between liberals and conservatives, the Insiders’ agenda wins either way. The only way to stop their continuing totalitarian advances is to organize a portion of the American grassroots under sound leadership to expose the deceptions.

### President Trump

President Trump has certainly initiated several actions that appear, at first glance, to advance his promises. It remains to be seen which, if any, will

bear positive fruit. Of course, they all garner a negative reaction from the revolutionaries.

Let's look at one, particularly popular with conservatives, the decision of his administration to lift the federal transgender bathroom guidance on our nation's schools, imposed by President Obama. According to AP (2-21-17):

The administration came down on the side of states' rights, lifting Obama-era federal guidelines that had been characterized by Republicans as an example of overreach.

Without the Obama directive, it will be up to states and school districts to interpret federal anti-discrimination law and determine whether students should have access to restrooms in accordance with their expressed gender identity and not just their biological sex.

"This is an issue best solved at the state and local level," Education Secretary Betsy DeVos said. "Schools, communities and families can find — and in many

cases have found — solutions that protect all students."

But the organized agitation for transgender "rights" is not about solutions or protecting transgender students, it's about revolution — aided by cultural revolution. If you satisfy one set of demands by revolutionaries, they just up the ante with new demands.

Although the Obama "guidance" carried no force of law, it led to numerous lawsuits. According to AP, "The reversal is a setback for transgender rights groups, which had been urging Trump to keep the guidelines in place."

It would be nice, therefore, to assume that President Trump will now defend traditional values against the cultural revolution. However, an "Exclusive" report by the Internationalist *Foreign Policy* raises serious doubts:

The Trump administration has decided to keep President Barack Obama's top advocate for gay rights issues at the State Department in defiance of evangelical groups who called for his immediate expulsion, *Foreign Policy* has learned....

The [Special Envoy for the Human Rights of LGBTI Persons] position was created during the Obama years to fight back against the discrimination of lesbian, gay, bisexual, and transgender people around the globe....

Trump's secretary of state, Rex Tillerson, pushed the Boy Scouts of America to be open to gay rights when he served as national president from 2010 to 2011. In 2013, while he served on the executive board of the Scouts, it rescinded the ban on gay scouts.

### **A New Trump Appointment**

Trump's new national security adviser, replacing Michael Flynn, is Army Lt. General Herbert Raymond McMaster. McMaster, a decorated soldier and West Point graduate, has been on the CFR roster for several years. Not

surprisingly, the McMaster selection received high marks from ABC's *Good Morning America* (2-21-17):

[McMaster is] considered a creative thinker in intelligence circles, and his counterinsurgency strategies in Iraq led to the U.S. Army securing the city of Tal Afar in 2005.

## Scoring the 115th Congress

With the House, Senate, and presidency in GOP hands, the GOP will now have difficulty posturing. GOP support for any serious measure will be expected to result in law or questions will be raised.

In the last Congress, many posturing measures passed by the GOP House never saw light in the GOP-controlled Senate. GOP senators could argue that they would have been dead on arrival in the White House and were therefore of little consequence. But that excuse is no longer available.

So far, President Trump has signed four measures into law (115-2 through 115-5, see the “Public Laws” link on our submenu of “Helpful Government Sites”), but none are all that significant.

As soon as there are good votes to score in the 115th, we will do so. In the meantime, we urge members to print and distribute the 114th Congress scorecards of their more senior representatives.

If you’ve not yet contacted all your state legislators this session, we have work for you! The battle against an Article V Con-con is raging, and you need to let those legislators know

where you stand.

To equip you to explain to them why an A5C (Article V Con-con) would be both a generally phony and extremely dangerous “solution,” we’ve posted a new article that summarizes the case against an A5C. As an easy read, it will help not only to remind you of the main problems with a Con-con, but also to provide your legislators a brief they may quickly read themselves.

What we are seeing on the battlefield is that, while we’ve had some victories, we’ve also seen some measures move like greased lightning through much of their legislatures. Indeed, as of this writing we have three measures on the verge of passing, in Utah and Wyoming.

The lesson for us is that we must contact our state legislators WHETHER OR NOT there is a measure currently live in our state legislature. The best defense is for us to go on the offense, and educate our legislators about the foolishness and danger of an Article V Con-con. Please use our new article, go forth, and do so!
